RESIDENTIAL POOL PUMP REBATE

Two-Speed or Variable Speed VSD Pool Pump	\$200
up to 3 horse power	one rebate every 3 years

POOL PUMP Rebate Criteria

1. Replacing an existing pool pump and motor with a new high efficiency two-speed or a new high efficiency variable speed motor to receive a rebate.
2. All pumps must be UL listed and installed in accordance with the National Electric Code.
3. Equipment and materials must meet or exceed all applicable local, state, and federal standards.
4. Two-speed pumps are defined as those that have two distinct operating speeds.
5. Variable speed pumps are defined as those that have a variable speed drive which allows the pump to operate at a wide range of speeds.
6. Rebates are for motors rated up to 3 horsepower or less installed on existing in-ground pools only. No new construction.
7. Above-ground pool, pond, pool cleaner/booster, spa and water feature pumps do not qualify for the rebates.
8. Pumps that were purchased for resale, used pumps, leased or rented pumps, pumps won as prizes or given as gifts, will not qualify for a rebate.
9. One pool pump rebate per household every 3 years.
10. More than one pump per household will need pre-approval.

Pool Conservation Tips:

1. **Check the length of time and time of day your pool pump is operated so it isn't operating longer than necessary or at peak demand hours 2 pm - 8 pm.**
2. **Clean your pool pump as recommended by the manufacturer. Debris can clog the pump and draw more energy.**
3. **Follow the manufacturer's guidelines for the frequency of backwashing. Excessive backwashing wastes energy.**
4. **Install a pool cover to help prevent evaporation, decrease cleaning time, and reduce heat loss.**
5. **Inspect and clean the heat exchanger on your pool heater regularly. An encrusted heat exchanger reduces the heater's efficiency.**
6. **Reduce pool and patio lighting, leaving on sufficient lighting for safety needs.**
